GENDER HARASSMENT COMMITTEE

The Committee deals with issues relating to sexual harassment at the Government Medical College and General Hospital, Narayanpet. It is applicable to all the Students, Staff and Faculty. A complaint of discrimination or sexual harassment may be lodged by the victim or a third party. A written complaint may be addressed to the Chairperson/Member Secretary of the Committee. If the complaint is made to the Director/Chairman of the Institution or any of the Committee Members, they may forward it to the Member Secretary of the Committee against Sexual Harassment. Here it should be noted that according to the Supreme Court guideline Sexual Harassment can be defined as "unwelcome" sexually determined behaviour (whether directly or by implication) as:

- a) Physical contact and advances
- b) Demand or request for sexual favours
- c) Sexually colored remarks
- d) Showing pornography
- e) Other unwelcome physical, verbal or non-verbal conduct of a sexual nature (Vishaka judgment by Supreme Court)
- f) To recommend appropriate punitive action against the guilt.

The following are also considered as Sexual Harassment and is covered by the committee

- a) Eve-teasing.
- b) Unsavoury remarks.
- c) Jokes causing or likely to cause awkwardness or embarrassment.
- d) Innuendos and taunts.
- e) Gender based insults or sexist remarks.
- f) Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and the like.
- g) Touching or brushing against any part of the body and the like.
- h) Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets or sayings.
- i) Forcible physical touch or Physical confinement against one's will and any other act likely to violate one's privacy.

It is mandatory for every Medical College in India to have a Gender Harassment Committee, as per regulations of National Medical Council, 2020 also.
